GILAS BASKETBALL 2017 – SBP CUP 5'10 AND BELOW RULES AND REGULATIONS

1. NAME OF THE TOURNAMENT

- Gilas Basketball 2017 – SBP Cup (5'10 and Below)

2. TOURNAMENT OBJECTIVES

- To foster sportsmanship and camaraderie among Filipinos and other nationalities working and living in Singapore.

3. PLAYER ELIGIBILITY AND TEAM REQUIREMENTS

- To be able to participate in the tournament, individuals must meet the following requirements:
 - Individual residing in Singapore holding a valid visa.
 - Players who have played professionally are not eligible.
 - Players' maximum height must be 177.80 cm or 5'10 feet.
 - Team managers / representatives must ensure that all players meet the required height. Players who do not meet the required height are **not allowed** to play in the tournament.
 - Team managers / representatives must submit the player's full name and jersey numbers.
 - Each team should be composed of 12 players minimum and 25 players maximum.
- During the competition, only registered players are allowed to represent their team.
- Once the competition has started no replacement or amendment of players is allowed.

4. PERIOD OF TOURNAMENT

- The competition will start on 15 October 2017. The Tournament Committee reserves the right to change the date and time of the fixtures.
- Fixtures will be posted in gilasbasketball.com when it is finalized and all teams will be notified thru our official Facebook Page ([Gilas Basketball League Singapore](#)).

5. TOURNAMENT VENUE

- The competition will be held at Yusof Ishak Secondary, West Spring Secondary School, Anderson Secondary School or Jurong West Secondary School. The Tournament Committee reserves the right to change the venue for the competition.

6. TOURNAMENT FORMAT

- Please refer to Facebook post for the format.

7. UNIFORM

- Official team uniforms must be worn properly at all times when playing.
- During positioning round – Additional 2 points will be awarded to the opposing team on each player that does not wear complete uniform (e.g. 2 players not wearing complete uniform, additional 4 points to the opposing team). Points will be added once the person becomes a player (from being a substitute to player).
- During playoffs – Players without complete uniform are **not allowed to play**.
- Players from the same team are not allowed to wear the same jersey number. Only one (1) player is allowed to play.
- Registered player numbers can be from 0 to 99 (including 00). It must not be more than two (2) digits.
- Players must wear the same jersey number as stated on the team registration form.

8. TOURNAMENT RULES

- The competition shall be conducted in accordance to FIBA Rules (effective October 2017).

9. GAME ABANDONMENT

- In the event of unsafe or unforeseen circumstances, it shall be the decision of the referee to stop or terminate the match.
- In the event of an abandoned game, the game time, score, and statistical records will be retained and continued when the match resumed at a later date and time.
- In a rescheduled game, teams may only use players and coaches who were listed for the original game that was abandoned.

10. PROTEST PROCEDURE

- If, during a SBP official competition, a team believes its interests have been adversely affected by a decision of an official [referee or umpire(s)] or by any event that took place during a game, it must proceed in the following manner:
 - The captain (CAP) of that team shall, immediately at the end of the game, inform the referee that his team is protesting against the result of the game and sign the scoresheet in the space marked 'Captain's signature in case of protest'.
 - To make this protest valid, it is necessary for the official representative of the national federation or the club to give confirmation of this protest in writing. This must be made within 20 minutes following the end of the game.
 - Detailed explanations are not necessary. It is sufficient to write: 'The national federation (or club) X protests against the result of the game between the teams X and Y'. Then he shall deposit with the SBP representative or with the President of the Technical Committee, a sum equivalent to SGD 500.00 as security.
 - The national federation of the team or the club in question must submit to the SBP representative or to the President of the Technical Committee the text of its protest within 1 hour following the end of the game.
 - If the decision of the Technical Committee is in favour of the protesting team, the deposit will be refunded.

11. REGISTRATION FEE

- No team will be allowed to play without posting the registration fee of S\$750.00.
- Teams must make a non-refundable reservation fee of S\$100.00 to guarantee a slot.
- Teams must pay S\$500.00 on or before the opening day (15 October 2017). The balance of S\$150.00 must be settle after the positioning round (before the playoffs starts).
- We will strictly enforce the no pay-no play policy.
- Refund is not allowed once the tournament has started or in such case where the team gets disqualified.

12. INSURANCE COVERAGE

- It is the responsibility of the teams to provide necessary insurance coverage for their officials and players. The organizer is not liable for any injuries or accidents occurred during the tournament.

13. AWARDS AND PRIZES

- The Champion will receive a trophy, 25 medals and cash prize of S\$ 500.00
- 1st Runner up will receive a trophy, 25 medals and cash prize of S\$ 300.00
- 2nd Runner up will receive a trophy, 25 medals and cash prize of S\$ 200.00

14. OTHER RULES

- While all reasonable precautions will be taken, Samahang Basketbol ng Pilipinas, Inc (Singapore), its staff, and agents will not be responsible or in any way liable for any death, disability, personal injury, loss of property, or any other loss arising from any cause related to or in the course of the tournament.
- Personnel involved in unsportsmanlike behaviour that causes damage to the reputation of the game will be banned for the duration of the tournament.
- In the event of any questions or matter arising out of any point, which is not expressly provided for in any of the rules governing the tournament, the decision of the Tournament Committee shall be final.
- The Tournament Committee reserve the rights to make changes, to add, delete and/or vary the said rules at any time they deem fit.
